

EDSymposium 2014 Scholarships

The SDA Orange County Chapter is offering two \$1,000 scholarships to attend the 2014 SDA National Convention (EDSymposium14).

The SDA National Convention Scholarship program has been created to provide financial assistance for the **EDSymposium14 registration fee and other convention related expenses** to qualifying members for the express purpose of participating in educational programs during the EDSymposium14.

This year the convention will be held in **Nashville, Tennessee** from Wednesday, May 14th through Saturday, May 19th. There will be 20 hours of continuing education offered in various professional emphasis groups: Finance, Human Resources, Office Administration, Marketing, Project Management, and other leadership and professional development activities scheduled throughout the week.

The convention will be kicked off with a "Denim & Diamonds" Welcome Reception on Wednesday night and a couple of Nashville tours are available on Friday afternoon. The final event of the conference will be the installation of the new Executive Committee and the Awards Banquet.

Eligibility Requirements

The following criteria will be used in evaluating all applications for the 2014 Scholarships:

- Applicant must be a current SDA member in good standing.
- Applications must be received no later than Friday, February 21, 2014. Applications received after that date, regardless of postmark, will not be considered.
- If selected, the applicant must provide a written synopsis of their experience at the conference for publication in the Chapter's newsletter and website.

Judging will be completed by February 28, 2014, and the recipient will be notified the same day. The scholarship may be applied toward the registration fee and other convention-related expenses for the current National SDA convention (EDSymposium14) only. If not used, the scholarship will be forfeited. Please note that only the registration fee will be paid in advance. **The remainder of the scholarship** will be in the form of reimbursement of other convention-related expenses (hotel, airfare, meals) up to the scholarship limit and subject to the submission of a newsletter article and travel receipts.


This year, executives from Toyota wanted to highlight and celebrate all that Toyota is, as well as how Toyota employees give back throughout the year.


