TWEETING!

Would You Like to Stay Connected with EDSymposium10?

If you can't make it to this year's convention, or if you'll be there but can't get to every session, or maybe you just don't want to have to take your own notes... SDA's Connections Committee will be 'tweeting' throughout the sessions to keep everyone in the loop with the informational tidbits that will be shared at EDSymposium10 in Las Vegas!

You should be able to pick up an idea of what people are saying, the sort of advice the speakers are offering and the questions people are asking. It is even possible to 'tweetback' with your questions for someone at the conference to ask on your behalf. Twitter can help you get a taste of what you're missing and tap a truly expert source.

So What Is Twitter?

Twitter is a real-time short messaging service that asks one question, "What's Happening?" Answers must be under 140 characters in length and can be sent via the web, mobile texting, or instant message. SDA members can use Twitter to stay connected with co-workers and friends, as well as keep up with real-time developments in the A/E/C industry.

Getting Started

How to sign up. Creating a Twitter account is simple.

- 1. Visit www.twitter.com, and click the "Sign Up Now" button. Fill out the form with your information. As always, if any of this is confusing, we on the Connections Committee are ready to give assistance; just ask.
- 2. See if your friends are on Twitter. This step allows Twitter to access your e-mail accounts to help you find your friends. Click "skip this step" if you're uncomfortable with Twitter accessing your e-mail accounts.
- 3. Look to see who else is on Twitter. Start following them! When you first open your account, Twitter will suggest users who you may be interested in following. When you follow a user, you will receive their real-time messages in your Twitter feed. Click "skip this step" if you don't like any of the recommendations.
- 4. Customize your account. Choose "Settings" from the menu at the top of your page. Click through the various tabs to choose a profile photo, change the design of your profile page, make your account private, and much more.

In the months leading up to EDSymposium10, the Connections Committee will continue to provide how-tos and answer any questions you might have regarding the whole tweeting process. A new hashtag has been created for this event #sdanational (not case sensitive). A hashtag is a simple way to catalog and connect tweets about a specific topic. They make it easier for users to find additional tweets on a particular subject, while filtering out the incidental tweets that may just coincidentally contain the same keyword. So set up your twitter account now (http://twitter.com), and maybe even download tweetdeck (http://www.tweetdeck.com) to help you follow #sdanational.

SUCCESSFUL PRESENTATIONS

So you've taken the plunge by raising your hand to volunteer to make a presentation. Now what?

First of all, congratulations! You've taken the first step. Secondly, there are a number of steps you can take to make your presentation a worthwhile event for both you and your audience. Here are some great tips taken from the National SDA web site.

- 1. **Prepare.** Do your research. Write out your presentation. Design your Power Point slides and above all, PRACTICE.
- Consider Your Audience. Make sure you keep your audience in mind while writing your presentation. What can you teach them? What do they already know? What do they want to get out of this?
- 3. **Proofread.** If copies of your presentation will be given out to your audience, make sure that there are no typos or grammatical errors.
- 4. **Dress Appropriately.** This is the perfect time to wear your suit. If you want to be taken seriously, dress the part.
- 5. **Turn Off Your Cell Phone.** If you don't and you get a call in the middle of your presentation, your audience will not take you seriously.
- 6. **Breathe!** This is a very simple way to calm your nerves and slow your heart rate.
- Do Not Rush. Take your time to make your point. Don't drag out your message, but don't rush through it so that people are left wondering what you just said.
- 8. **Do Not Read Your Presentation.** Nothing is more annoying than listening to someone read their PowerPoint slides.
- **9.** Fake It. You might be extremely nervous, but do not show it. Act confident. Envision someone you admire, and pretend you are that person.
- **10. Enjoy Yourself!** You know the subject matter better than your audience, so convey a valuable message, crack a few jokes, and relax.
